#### Description of necessary first aid measures

Eye contact

## Specific hazards arising from the chemical

: Flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. #### Methods and materials for containment and cleaning up

#### Small spill

### Section 7. Handling and storage

#### Precautions for safe handling

#### Protective measures

Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapor or mist. Avoid release to the environment. ## Section 8. Exposure controls/personal protection

## Appropriate engineering controls

: Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
