4. First aid measures

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. 6. Accidental release measures

Environmental precautions

Methods and materials for containment and cleaning up

Small spill
