# Section 4. First aid measures

Skin contact	: Wash with plenty of soap and water. Remove contaminated clothing and shoes. Wash contaminated clothing thoroughly with water before removing it, or wear gloves. # Section 7. Handling and storage

Precautions for safe handling
