Section 4. First aid measures

Description of necessary first aid measures

Eye contact: Set medical attention immediately. Call a poison center or physician. Immediately

flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes.

Chemical burns must be treated promptly by a physician.

Inhalation: Cet medical attention immediately. Call a poison center or physician. Remove

Methods and materials for containment and cleaning up

Small spill

Section 7. Handling and storage

Precautions for safe handling

Protective measures
