Section 4. First aid measures

Description of necessary first aid measures

Immediately flush eyes with plenty of water, occasionally lifting the upper and lower **: Eye contact** eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention if irritation occurs.

Remove victim to fresh air and keep at rest in a position comfortable for breathing. : Inhalation If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. Section 5. Fire-fighting measures

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Move containers from fire area if this can be done without risk. Use water spray to keep fire-exposed containers cool.

Methods and materials for containment and cleaning up
