## 4. First aid measures

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. ### 4. First aid measures

#### Ingestion

## 6. Accidental release measures

#### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

#### Methods and materials for containment and cleaning up

Small spill

Large spill

Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). ## 7. Handling and storage

#### Handling

**Protective measures**

## 7. Handling and storage

#### Conditions for safe storage

: Store in accordance with local regulations. Store in a segregated and approved area.
