### **Description of necessary first aid measures**

Eye contact

#### Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. ### Large spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. #### Precautions for safe handling

# Appropriate engineering controls
