4. First aid measures

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Protection of first-aiders

5. Fire-fighting measures

7. Handling and storage

Handling

Protective measures
