#### **Description of necessary first aid measures**

**Eve contact**

## Section 5. Fire-fighting measures

#### Special protective actions for fire-fighters

: Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. #### Methods and materials for containment and cleaning up

Small spill

## Section 7. Handling and storage

#### Precautions for safe handling

**Protective measures**

## Advice on general occupational hygiene
