#### **Hazard statements**

### Section 4. First aid measures

#### Skin contact

#### Ingestion

Specific hazards arising from the chemical

### Section 7. Handling and storage

### Precautions for safe handling

#### Protective measures

: Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapor or mist. Avoid release to the environment. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Do not enter storage areas and confined spaces unless adequately ventilated. # Appropriate engineering controls
