Description of necessary first aid measures

Eye contact

Ingestion

Section 5. Fire-fighting measures

Specific hazards arising from the chemical

: Flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. This material is harmful to aquatic life with long lasting effects. Section 7. Handling and storage

Precautions for safe handling

Protective measures
