### Description of necessary first aid measures

If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. If unconscious, place in recovery position and get medical attention immediately.

#### Methods and materials for containment and cleaning up

#### Small spill

# Section 7. Handling and storage

#### Precautions for safe handling

#### **Protective measures**

# Appropriate engineering controls
