4. First aid measures

Inhalation	: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Get medical attention. If unconscious, place in recovery position and get medical attention immediately. 4. First aid measures

- Protection of first-aiders** : No action shall be taken involving any personal risk or without suitable training. 5. Fire-fighting measures

7. Handling and storage

Handling

Protective measures : Put on appropriate personal protective equipment (see Section 8).
