4.1 Description of first aid measures

Eye contact

Skin contact

5.2 Special hazards arising from the substance or mixture

Hazards from the substance or mixture : Flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. 5.3 Advice for firefighters

Small spill

SECTION 7: Handling and storage

7.1 Precautions for safe handling

Protective measures

Eut on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used.
